#### SELECTIONAL CONSTRAINTS OF YORUBA VERBS OF FARMING

#### Abstract

This paper attempts to contribute to the existing arguments on verb-nominal collocations. Verb-nominal collocations refer to the patterns of collocations of verbs and their internal arguments. This notion has been studied, although not exhaustively in existing literatures. Emerging data from verbs of farming in Yoruba show that some verbs exhibit some idiosyncratic behaviour. A careful study of the verbs employed in farming in Yoruba shows that some verbs may share similar semantic notion, yet exhibit different patterns of collocations with object arguments. Thus, the general opinion that a verb determines the features of the noun it subcategorises for is only an integral part of the grammatical role of the verb in verb-nominal collocations. Advancing these arguments further, this paper seeks to unravel the semantic underpinnings and variations in the collocation patterns of the Yoruba verbs of farming. We explore the object arguments of these verbs and investigate their similarities/differences to give a clearer understanding of the grammatical roles the verb play in complement structures.

#### 1. Introduction

Yoruba verbs have been studied, although not exhaustively (Bowen 1888, Bamgbose 1964; 1966, and Oyelaran 1976, Awobuluyi 1978, Adeyeye and Abiodun 2019, etc.). These studies reveal that the Yoruba verbs exhibits some idiosyncratic characteristics. Over time, linguists have argued that the Yoruba verbs are not inflectional in nature. All through the variations of person, number, mood, and tense, the Yoruba verbal root remains unchanged. (Bowen 1888, Bamgbose 1966, and Oyelaran 1976). Research has also shown that the Yoruba verbs can be split (split verbs). When used in an object, the verb can split into two halves. (Awobuluyi 1978:53).

However, emerging data from the Yoruba verbs of farming presents new peculiarities which justify this study. The Yoruba verbs of farming constitute a sub-class of the Yoruba verbs. Some of the Yoruba verbs of farming have generic terms and variants. These verbs follow an organized unusual pattern in their collocations with their object complements. The verbs impose peculiar syntactic and semantic restrictions on the NP(s) that they collocate with. To ascertain the patterns of constraints placed by the Yoruba verbs of farming on NP complements, we intend to do an analysis of the subcategorial frames of their verbs in Section 3 of this paper. To account for the subcategorial frame of each verb, we shall set up a paradigm of feature matrices for the verbs and NPs they collocate with. Different feature-based theories of meaning consider meaning in terms of feature lists, those properties of meaning which, taken together, express the meaning of a word in some way. These accounts assume not only the existence of the definitions for concepts in terms of core features, but also in another set of relevant features. These features reflect information that is not necessarily part of the definition itself. (Rosch and Mervis, 1975; Smith, et al (1974); Collins and Quillian, 1969; Jackendoff, 1990; Minsky, 1975; Norman and Rumelhart, 1975; Shallice, 1993; Smith and Medin, 1981). As such, description in terms of features i.e. subcategorial features will enable us to provide an adequate account of the inherent grammatical restrictions which each verb imposes on its choice of complement(s)

## 2. Methodology

The paper adopts both direct and indirect systems of data collection in this research. The informants were sourced from native speakers of Yoruba

within the age range of 30 - 65 years. The older speakers of the language were deliberately engaged because the younger generation may not be able to give in-depth information about verbs of farming given that most of them don't part-take in farming. The farmers were interviewed individually and in groups at pre-arranged locations at times convenient for them. The data collection was done using 1,700 SIL comparative African wordlist (SILCAWL). Unlike other wordlists, the SIL comparative wordlist amongst other advantages gives a plethora of corpus for different spheres of life i.e. agriculture, commerce, travel and transportation, tailoring and weaving, man's physical being (body parts), medicine, etc. Terms for tools, crops and farming processes were collected with their examples in contexts. After

that, the informants were asked to supply any other term not captured on the wordlist. Lastly, two veteran farmers within the ages 60-65 were interviewed to corroborate and verify the data collected.

For the secondary source, published works on farming in Yoruba, e-books on farming practices in Yoruba and the Yoruba dictionary were consulted. The data were observed after collection and the verbs were categorized into eight groups based on shared semantic notions and analyzed following their argument selectional restrictions: verbs of planting, verbs of harvesting, verbs of reproduction, verbs of maturity, verbs of spoilage, verbs of peelage, verbs of clearing and verbs of breaking.

### 3. Subcategorial Frame of Yoruba Verbs of Planting

The verbs of planting are verbs that describe the events involved in the process of crop planting. These group of verbs have two kinds of terms, a generic term and its variants. The generic terms encapsulate general ideas or state of a phenomenon. On the other hand, the variant terms describe an integral idea or state of a phenomenon. The generic term for planting in Yoruba is "*gbin*" "to plant" as shown in the example below in 1(a)

The subcategorial features of the word *gbin* above show that it encodes features which describe the different processes of planting. This explains why it collocates freely with different types of crops. Examples in context are considered below.





Following the data above, the feature [+heap] in (1b) captures crops that are planted in a heap. It subcategorises for an object complement with [+tuber] feature and also a covert argument i.e. an instrument used to dig up the heap not represented in open syntax but exits in LF interpretive level of the native speaker (i.e. in the mind). The feature [+spread] in (1c) captures crops that are planted by spreading them on the soil. It subcategorises for an object complement with the [+seed, +tiny] features. The feature [+deep] in (1d) captures crops planted in the soil. It subcategorises for object complement with the [+seed, +tiny] features crops that are usually transplanted e.g. pepper and tomatoes. These inherent features of the generic verb explain why it collocates freely with the object complements. However, the verb *gbin* has two variants; *fon* and *lo* which contradict the collocation pattern exhibited by the generic verb. To buttress this claim, let us consider the subcategorial frame of each variant below,



The feature [+spread] restricts the kinds of crops it collocates with to crops planted by spreading their seeds on the soil e.g. tomatoes, pepper. See example below



The feature [+replant] of the verb  $l \phi$  restricts the kinds of crops it selects to crops that go through two processes of planting i.e. spreading and replanting e.g. pepper, tomatoes, cocoa, etc. see example below

b. Òjó lọ *l*ó ata Ojo go replant pepper "Ojo went to transplant pepper"

Given the analysis of the verbs of planting above, only the generic verb "gbin" collocates freely with all crops while its variants are restrictive in collocations. Collocating then freely will result in ungrammatical constructions as shown in examples 2c and 3c above. The sentences in 2c and 3c above are ungrammatical because the object NP "yam" is not licensed by the subcategorial features of the verbs "fón, ló". Aside from the fact that the subcategorial features of these verbs as shown above are at variance with the subcategorial feature of the object NP, the verb in (2c) selects only overt arguments as opposed to the [+tuber] feature requirement explained earlier. Although, the verb in (3c) selects both overt and covert arguments. In the LF of the native speaker, it is assumed that the instrument here (covert argument) is used for digging the soil into a deep not a heap.

#### 3.1 Subcategorial Frame of Yoruba Verbs of harvesting.

The verbs of harvesting are verbs that describe the different processes involved in harvesting a crop. These group of verbs also have a generic form and variants forms. The generic term for harvesting in Yoruba is *'kórè'*. Let us consider its subcategorial frame in 4a below.

The subcategorial features of the word  $k \acute{ore}$  above show that it encodes features which describe the different processes of harvesting. This explains why it collocates freely with different types of crops. Examples in context are considered below.

The contexts of usage of the verb  $k \acute{ore}$  show that the verb collates freely with all crop types because it encodes features which describe the different processes of harvesting. In (5a) The feature [+dig] specifies that the harvesting of the relevant crop involves the process of digging. Hence, it subcategorises for an overt Object NP with the [+tuber] feature and a covert argument with the [+instrument] feature. In (5b and c) the feature [+pluck] describes the action of plucking. It also encodes the meaning that the crop to be harvested are not

yet severed from their relevant trees or plants. It subcategorizes for Object NP with the [+fruit or +vegetable, +seed] feature. In (5d, e and f) the feature [+cut] describes the action of severing the crop from the relevant tree or plant by cutting with instrument. It subcategorises for an object NP with the [+fruit or +vegetable] feature and a covert argument with the [+instrument] feature. (5g) The feature [+pick] captures the fact that the crops are already severed from their plants and the crops are rather small. It sucategorises for object NP with the [+fruit, -instrument] features. In (5h) The feature [+tear] describes the action of tearing the crop from its stem. It subcategorises for object complement with the [+stem, -instrument] features.

The verb  $k \delta r \dot{e}$  has eight variants;  $w \dot{u}$ ,  $k \dot{a}$ ,  $j \dot{a}$ ,  $s \dot{a}$ , k o, y a and s a. to establish their collocation patterns, let us consider the subcategorial frame of each variant below.



The feature [+dig] of the verb  $w\dot{u}$  restricts the kinds of crops it collocates with to crops harvested by digging them out of soil with an instrument e.g. yam, cassava, potatoes, cocoa yam, etc. see example below

The feature [+pluck], [+height] of the verb  $k\dot{a}$  restricts the kinds of crops it collocates with to crops that are plucked from height usually above arm's reach with an instrument or climbing in order to reach them e.g.

The features [+pluck], [-height] of the verb  $j\dot{a}$  restrict the kinds of crops it collocates with to crops that are plucked from height usually at arm's reach and does not require an instrument or the process of climbing in order to reach them e.g. vegetables

The subcategorical feature [+cut] of the verb sá restrict the kinds of crops it collocates with to crops harvested by cutting the produce with an instrument e.g. cocoa, pawpaw, plantain, banana, sugarcane, etc. see example below

The verb ko also means to harvest by cutting with an instrument coupled with the feature [+pull] these features restrict the kinds of crops it collocates with to crops harvested by cutting followed by intermittently pulling the fruit from its stem until it is finally severed. An example of such a crop is the palm fruit. Hence, collocating this verb freely will result in ungrammatical construction. See examples in context below

The feature [+tear] of the verb *ya* restricts the kinds of crops it collocates with to crops harvested by tearing its produce off its plant e.g. corn. See example (11b) below for illustration

The feature [+pick] of the verb *sa* restricts the kinds of crops it collocates with to crops that falls off their plants on their own accord e.g. orange, fruit, pea, etc.

In the analysis of the verbs of harvesting above, it can be observed that only the generic verb "*kórè*" collocates freely with all crops but underlyingly may or may not select a covert argument in open syntax as illustrated in examples 5a-h. However, its variants are restrictive in collocations owing to the fact that they communicate specific harvesting process as illustrated in examples (6b-f), (7b-e), (8b-d), (9b-e), 10b-e), (11b-d) and (12b-c) above.

# 3.3 Subcategorial Frame of Yoruba Verbs of Reproduction

Our data shows that there is no generic term for the verbs of reproducing in Yoruba. Two terms are usually employed for these verb group; *so* "reproduce" and *ta* "reproduce". Both verbs mean the same thing but cannot collocate with the same crop. The verb *so* collocates with produce that grows above the soil while the verb *ta* collocates with produce that grow below the soil. See their subcategorial frames below for more illustration.



Examples of crops in this category are orange, tomatoes, pepper, cocoa, cocoanut, pawpaw, etc. see it examples in usage below.

The feature [+below soil] of the verb *ta* restricts the kinds of produce it collocates with to produce that grows under the soil e.g. tubers. See its examples in usage below.

The analysis in example (13b) show that the verb *so* collocates with fruits and fruity vegetables while example (14b) shows that the verb *ta* collocates with tubers. Aside from surface illumination presented in the analysis above, these verbs of reproduction cannot also be used interchangeably because they provoke different intuitive thoughts at the LF interpretive level of the native speaker. It is assumed that the verb *so* is associated with crops which may or may not subcategorise for an underlying argument i.e. an instrument for harvest. It does not require an instrument where the reproduced crop is within arm's reach as seen in example (13b) and where it is out of arm's reach as seen in example (13d) it would require climbing or an instrument e.g. a long wooden stick. On the other hand, it is assumed that the verb *ta* is associated with crops which in this case is usually a machette or a hoe. All of these explain why examples (13c, d and 14c) result in ungrammatical and unacceptable constructions in the language.

## 3.4 Subcategorial Frame of Yoruba Verbs of Maturity

Maturity here is in reference to when the crop has reached its harvest stage. In this regard, two forms of verbs are usually employed;  $p \phi n$  'ripe' and  $g b \phi$  'mature'. The first verb  $p \phi n$  collocates with a crop that changes its colour to indicate maturity, often times from dark green to light green, yellow or red. Below is its subcategorial frame for a clearer illumination of its features.



The feature [+colour] of the verb  $p \phi n$  restricts the kinds of crops it collocates with to crops that change colour to indicate maturity e.g. orange, pawpaw, tomatoes, pepper, etc. See its usage in examples below.

The second verb gbo collocates with crops that do not change colour to indicate maturity. Its subcategorial frame is shown below for a clearer illustration of its features.



The subcategorical feature [-colour] of the verb  $gb\delta$  restricts the kinds of crops it collocates with to crops that do not change colour to indicate maturity e.g. tubers and leafy vegetable. See it usage in examples below.

- b. işu baba ti *gbó* Yam Baba ASP. mature "Baba's yam has matured"
- c. Efo ti mo gbin ti *gbó* Efo that I plant ASP mature "The vegetable that I planted has matured"

The analysis of the verbs of maturity above shows that the verb *pón* collocates with fruits and fruity vegetables because they change colour to indicate maturity while the verb *gbó* collocates with tubers, stems, leafy vegetable and grains because they do not change colour to indicate maturity. Hence, the native speakers

intuitively associate these verbs to their respective kinds object compliments

### 3.5 Subcategorial frame of Yoruba Verbs of Spoilage

Here, the word spoilage is used to refer to when crops weaken and eventually perish. The verbs of spoilage in Yoruba contain a generic term, *bàjé* and four variant forms; *rè*, *lù*, *rà*, *kó*, and *pón*. let us consider their subcategorial frames below.

Subcategorial frame of the verb  $b\dot{a}j\dot{e}$  shows that it collocates freely with all crop types because it encodes all the different features noticeable when a crop spoils. The subcategorial feature [+Weak] captures crops that become weak when they get spoilt. The feature [+Decay] captures crops that decays when they get spoilt. The feature [+Hard] captures crops that becomes hard when they get spoilt. Examples (17b-f) below show the kinds of crops the verb  $b\dot{a}j\dot{e}$  selects.

Examples (17b-f) reveal that the verb baje collocates freely with all crops because it encodes all the features of spoilage. However, let us consider the collocation patterns of its variants



The feature [+weak] of the verb rè above restricts the kinds of crops it collocates with to crops that become weak when they spoil e.g. orange, pawpaw, mango, vegetables, etc. See example below.

The features [ $\pm$ weak] and [+hole] of the verb  $l\dot{u}$  restricts the kinds of crops it collocates with to crops that become weak at one side with a hole when it spoils e.g. orange, mango, etc. See example below for its usage in context.

The feature [+decay] of the verb  $r\dot{a}$  restricts the kinds of crops it collocates with to crops that decay when they get spoilt. e.g. tubers. See example in context below.

The verb  $k\delta$  in example (21a) means 'to become strong'. It collocates with crop that becomes hard when it spoils. See its subcategorial frame below.



The feature [+hard] of the verb  $k \dot{o}$  restricts the kind of crop it collocates with to crop that hardens when it spoils e.g. okro. See example in context below



The feature [+colour] of the verb *pón* restricts the kinds of crops it collocates with to crops that change colour when they spoil e.g. leafy vegetable. See example in context below.

b. ¢fó orí igi yẹn ti pón Vegetable head tree that. ASP. hard "The vegetable on that stem has spoilt".

The subcategorial frames of the verbs of spoilage above reveal that the generic verb *bàjé* collocates with all crops because it encodes all the features of spoilage. However, the subcategorial frames illustrated in examples 18a, 19a, 20a,21a and 22a reveal that its variants are restrictive in collocating with crops because they encode specific features of spoilage.

### 3.6 Subcategorial frame of Yoruba Verbs of Peelage

There is no generic term for the verbs of peeling because no single verbal encodes all the features of peeling. In this regard three different verbs are usually employed. They are be, ho, and bo. These verbs cannot be used interchangeably. The Yoruba language distinguishes how the process of peeling is done by employing different verbal terms. The verb be collocates with crops that are peeled by chopping off their back. Therefore, the verb subcategorises for a covert argument with the [+instrument] feature. The verb ho collocates with crops that are peeled by slicing off their back. Similarly, this verb subcategorises for a covert argument with the [+instrumen] feature . While the verb bo, collocates with crops that are peeled without a covert instrument. See their subcategorial frames below for more illustration.



The feature [+chop] of the verb *be* restricts the kinds of crops it collocates with to crops peeled by chopping off their back by repeated blow of a sharp instrument e.g. yam, cassava, etc. See its usage in the example

below.

The feature [+slice] of the verb  $h\dot{o}$  restricts the kinds of crops it collocates with to crops peeled by slicing off their back with a sharp instrument e.g. orange. See its usage in the example below.

The feature [-instrument] of the verb *bó* restricts the kinds of crops it collocates with to crops that can be peeled without an instrument. However, the act is carried out with the hand alone. Hence, the verb bó subcategorises for NP complement with the [+fruit] feature and a covert or underlying argument "hand" absent from open syntax but assumed and understood by the native speakers. examples of such crops are e.g. tangerine, banana, plantain, etc. we will now buttress our argument with the aid of a D-structure and S-structure using the example below.

"grandma is peeling banana.

The difference between the D-structure and the S-structure is the prepositional phrase structure capturing the underlying argument not represented on the S-structure. This is so because the economy of derivation condition compels the grammar of all languages to perform the most economical one. Thus, since native speakers' knowledge of these verbs implies an awareness of the existence of these underlying NP objects, it therefore becomes economical not to represent it in open syntax.

The analysis of the verbs of peeling above shows that the verbs be, ho and bo share the feature [+peel] but the verb bo does not require an instrument as such collocates with objects arguments that do not require instrument but still underlying picks up a covert argument for peeling as shown in example 25c above. the verbs be and bo share the features [+peel, +instrument] but the differences in their event acts' features; [±chop, ±slice] account for the variations exhibited in collocating them with object NPs. This explains why examples 23c and 24c are ungrammatical and unacceptable in the language. The object NP "yam" agrees with feature [+chop] while the object NP "orange agrees with the feature [+slice].

#### 3.7 Subcategorial frame of Yoruba Verbs of Clearing

By verbs of clearing, we mean verbs employed in Yoruba when removing weeds on the farm land. There is no generic verb in this regard. However, two verbs are employed. They are s dn and r d. They both mean "to clear" but encode different semantic underpinnings. Yoruba distinguishes between the sizes of weeds to be cleared by employing these terms. Let us consider their subcategorial frames with examples to buttress our argument.

In the analysis of the verbs of clearing above, the subcategorial frames of the verb  $s \dot{a}n$  and  $r \dot{o}$  reveal that they share the features [+clear and +instrument]. However, the subcategorial feature [+much] of the verbs  $s \dot{a}n$  in (26a) above restricts its collocation to unwanted plant cut with a perticular kind of instrument 'machette', not represented in open syntax but intuitively understood by naïve speaker as shown in example (26b) while the feature [-much] of the verb  $r \dot{o}$  restricts its collocation to weeds cut with a particular kind of instrument 'hoe' again not represented in open syntax but intuitively understood by naïve speaker as shown in example 26d. **3.8 Subcategorial Frame of Yoruba Verbs of Cracking** 

By verbs of cracking we mean verbs that denote breaking off the back of a crop in order to get it content. Yoruba distinguishes how this cracking is done by employing two terms; *sé and pa*. Let us consider their subcategorial frame with examples below for clearer illustration.



In the analysis of the verbs of cracking above, the subcategorial frames of the verb  $s\dot{e}$  and pa reveal that they share the features [+crack]. However, the feature [-instrument] of the verb  $s\dot{e}$  restricts the kinds of crops it collocates with to crops that require no instrument to crack their backs because their backs are usually soft. Hence, it will be ungrammatical to collocate crop which violate this feature with it, as shown in example (27c) above. However, the feature [+instrument] of the verb pa restricts the kinds of crops it collocates with to crops that require an instrument to break their backs because their backs are usually very hard. Collocating it with crops which contradicts this feature will result in ungrammatical and unacceptable construction in the language as shown in example (28c) above.

### 4.0 Conclusion

The discussion so far has exposed the idiosyncratic selectional properties of the verbs under investigation. These verbs have two distinct patterns of collocations with their NP objects. First, the verb determines the presence of the NP objects. The direct objects are overt but the covert objects are not represented in open syntax since the native speaker knowledge of these verbs implies an awareness of the existence of these underlying NP objects. The generic terms collocate freely with all crops. Secondly, the verb delimits the presence of an Np object. The variant terms are restrictive in their collocation with crops. The analysis above shows that the variations in collocation patterns are largely feature driven. Another point to emphasis here is that the generic verbs determines the presence of an NP object while the variant verbs not only determines but also delimits the presence of an NP object. Following from these, it suffices to say that Chomsky's selectional restriction rule can be expanded into two areas: macro-selectional restrictions and micro-selectional restrictions. The macro-selectional restriction rules determine the presence of the object complement while the

micro-selectional restrictions rules not only determines but also further delimits the object complement form. Over and above all, the issues handled in this paper points to the richness of the Yoruba verbal system that is yet to be fully explored.
