# A CRITICAL ANALYSIS OF INTERCESSORY PRAYERS AS PRACTICED IN THE ROMAN CATHOLIC TRADITION

#### Abstract

This paper critically analyzes the Roman Catholic practice of intercessory prayers to Mary and the saints in light of biblical teaching and the model of prayer presented by Jesus Christ, While Catholic theology upholds the Communion of Saints and the ability of glorified believers to intercede for the living, this paper argues that such practices lack explicit biblical support. Nowhere in Scripture are believers instructed to invoke the saints or Mary in prayer; rather, the New Testament consistently encourages direct prayer to God the Father through Jesus Christ, the sole mediator between God and humanity (1 Timothy 2:5; John 16:23). Drawing from both biblical texts and theological sources, this research contrasts Catholic tradition with the Reformation principle of Sola Christus, emphasizing Christ's exclusive mediatory role. It highlights how the Catholic use of apocryphal and extra-biblical sources stands in contrast with the biblical paradigm, which presents prayer as a Spirit-empowered, Christ-centered communion with God. The paper further critiques the assumption that saints in heaven are aware of or capable of responding to the needs of the faithful on earth, a notion unsupported by Scripture (cf. Luke 16:26). Through a qualitative methodology, engaging literature data from Scripture texts, church documents and theological analysis, this paper seeks to clarify whom Christians are biblically authorized to address in prayer. It aims to reorient the Church's prayer life toward the teachings of Christ and the apostolic witness, asserting that Scripture not tradition must remain the ultimate authority on matters of faith and practice. The paper recommends that Church especially its leadership and teaching ministries must return to the biblical model of prayer, which affirms that all believers have direct, unhindered access to God the Father through Jesus Christ alone.

#### Introduction

Prayer is one of the core doctrines and spiritual practices in Christianity. A proper model of prayer is central to sound doctrine and healthy Christian spirituality. It anchors faith and sustains the believer's relationship with God. Prayer is the means by which Christians communicate with the divine God, who is both the object of their faith and worship. Consequently, Christian prayers are directed to God alone (Dabney, 1878 and Hodge, 1873 and Grudem, 2020). The Bible states that believers do not always know how to pray as they should (Rom. 8:26). It is one thing to pray, and another to know what to pray for. Through the Holy Spirit, God enables believers to pray in accordance with His will. Christian prayer typically includes adoration, confession,

thanksgiving, and supplication each directed to God.

A proper model of prayer is necessary to avoid forms of prayer that deviate from God's will. The Bible teaches that some prayers go unanswered because they are not asked rightly or with the right motives (Jas. 4:2–3). Thus, a biblical model of prayer, offered with sincere intention, is essential for spiritual efficacy. The importance of proper prayer is demonstrated in the disciples' request for Jesus to teach them how to pray, inspired by His own consistent prayer life and the practices of John the Baptist's followers (Luke 11:1). When they failed to cast out a demon, Jesus attributed their failure to a lack of prayer and fasting (Matt. 17:21). Jesus emphasized that prayer must not be vain or repetitive, nor performed to

gain public attention. Rather, it is a sincere, private communication with the unseen God, who sees what is done in secret (Matt. 6:5–8).

In teaching His disciples, Jesus used personal pronouns "when you pray, pray to your Father" implying that prayer is personal and intimate (Matt. 6:6). Moses expressed a similar desire for universal access to God when he exclaimed, "I wish that all the Lord's people were prophets and that the Lord would put his Spirit on them!" (Num. 11:29, New International Version). Dugdale (2019) affirms the personal nature of prayer in her work on the Lord's Prayer, and Cockayne (2017) notes that prayer helps individuals transcend despair and grow in personal communion with God. Carson (2001) further supports individual prayer while recognizing that prayer shared among believers builds trust and intimacy.

## **Background to the Study**

The Roman Catholic practice intercessory prayer is grounded in its theology of the Communion of Saints, which includes the Church militant (earthly), the Church suffering (purgatory), and the Church triumphant (heaven). According to the Catechism of the Catholic Church (1994), saints in heaven, being united more closely with Christ, can intercede on behalf of the faithful, thereby contributing to the Church's holiness. Catholics cite Revelation 5:8 and 8:3-4 to support the view that the saints present the prayers of the faithful to God. Additionally, 2 Maccabees 15:12–16 recognized in the Catholic canon but not in Protestant Bibles provides precedent for the belief in intercession by the righteous dead. This practice is seen as consistent with the affirmation that the saints, though dead, are alive in Christ (Luke 20:38).

Conversely, Protestant theology especially within Reformed traditions emphasizes direct access to God through Christ alone. As stated in 1 Timothy 2:5, "There is one God and one mediator between God and mankind, the man Christ Jesus." Jesus Himself assures His followers: "Whatever you ask the Father in my name, he will give it to you" (John 16:23). These texts are understood to teach that prayer should be directed to God the Father through Christ, without the

involvement of saints or intermediaries. This theological contrast raises the question of whether the invocation of saints for intercession aligns with the New Testament's emphasis on Christ as the sole mediator. It also challenges the harmony between tradition and Scripture regarding mediation and the communion of saints.

#### **Statement of the Problem**

This study addresses the theological tension between the Roman Catholic practice of invoking saints for intercession and the biblical model of prayer taught by Jesus. While Catholicism upholds the doctrine of the Communion of Saints and the role of Mary and the saints as intercessors, biblical texts such as 1 Timothy 2:5, John 16:23, and Hebrews 4:14-16 emphasize direct access to God through Christ alone. Two central issues emerge: (1) Does Scripture affirm the intercession of saints in heaven on behalf of the living? While texts like James 5:14-16 encourage intercessory prayer among believers, there is no clear biblical precedent for the dead interceding for the living. (2) Does the practice of invoking saints supplement or compromise the exclusive mediatory role of Christ?

Ngwenya (2020), in his study of prayer in the Gospel of Luke, emphasizes Jesus' teaching of prayer as a personal and direct address to the Father. This aligns with the overall biblical portrayal of God's desire for intimate communion with each believer. This paper seeks to critically analyze these questions, assess the biblical and doctrinal foundations of Catholic intercessory prayer, and evaluate whether the practice aligns with the Christ-centered prayer model evident in Scripture and early Christian tradition.

# Scope of the study

This study begins with an examination of key biblical texts related to prayer and mediation, including John 16:23, 1 Timothy 2:5, and Revelation 5:8. These passages provide foundational insights into the New Testament model of prayer, emphasizing direct access to God through Christ. The analysis then turns to Catholic doctrines such as the Communion of Saints, the distinctions between *latria*, *dulia*, and *hyperdulia*, and authoritative teachings from the Council of

Trent and the Catechism of the Catholic Church. A comparative exploration follows, highlighting the differences between Protestant and Catholic perspectives on the concept of mediation. The study also evaluates the biblical and apostolic consistency of intercessory prayer to saints, assessing whether this practice aligns with early Christian teaching and Scripture. Finally, attention is given to the pastoral and devotional implications of praying to saints within contemporary Catholic life, considering how this tradition shapes the spiritual experiences of the faithful.

This paper limits itself to doctrinal and theological analysis, excluding sociological or empirical research.

#### Literature Review

**Thomas** Aquinas (1225-1274)distinguishes between three levels of veneration: latria (worship due to God alone), dulia (honor given to saints), and hyperdulia (a higher form of honor reserved uniquely for Mary, the Mother of God). Aguinas teaches that saints possess no power of their own but can intercede with God, akin to asking fellow believers to pray on one's behalf. Even when prayers are addressed to saints or Mary, they are ultimately directed to God, who answers prayer alone (Aquinas, Summa Theologiae, III, q. 25, a. 5).

Saint Augustine of Hippo (354–430) emphasized the appropriateness of seeking the intercession of saints and Mary. While he considered it inappropriate to pray for martyrs, since they are in God's presence, he affirmed the practice of asking for their prayers. He recognized Mary's unique role in salvation history and supported invoking her intercession, viewing the communion of saints as a spiritual unity of the faithful, both living and dead (Augustine, City of God, Book XXII). St. Anselm of Canterbury (1033-1109) reinforced this tradition, portraying saints as friends of God whose prayers are effective due to their closeness to Him. Anselm held deep devotion to Mary, referring to her as mediatrix, though always subordinate to Christ. For him, all grace and salvation come from God, but the saints participate in intercession (Anselm, Prayers and Meditations).

St. Robert Bellarmine (1542–1621), a major theologian during the Counter-Reformation, defended praying to saints and venerating Mary. He argued that saints in heaven, united with Christ, can intercede for the faithful, a belief grounded in Scripture and early Church tradition. Bellarmine emphasized that invoking saints constitutes veneration, not worship, and held a special devotion to Mary, referring to her as Queen of Heaven (Bellarmine, *Disputations on the Controversies of the Christian Faith*).

Karl Rahner (1904–1984) reaffirmed traditional Catholic teachings on saints but interpreted them within a modern theological framework. He viewed saints as symbols of God's grace and active participants in the Church's communal life. Their intercession reflects the communion of saints and a subordinate role in Christ's one mediation (Rahner, 1981). Joseph Ratzinger (Pope Benedict XVI) similarly upheld the practice of seeking saintly intercession as an expression of the unity of the Church. He maintained that the saints' prayers do not replace Christ's mediatorship but flow through Him, the one true Mediator (Ratzinger, 2000).

Pacwa (1994) explains that Catholics do not worship saints but ask them to pray to God on their behalf, stating: "What the Church does allow is praying to saints to ask for their intercession with the one true God" (p. 103). Catholics reject any form of conjuring the dead and affirm that the saints, though departed, are alive in Christ and capable of interceding for the faithful. The Catechism of the Catholic Church (1997) also supports this practice. Prayers like the *Memorare* reflect confidence in Mary's intercession: "Never was it known that anyone who fled to thy protection... was left unaided" (p. 645). Catholics believe saints present their petitions to God and that these prayers are effective due to their closeness to Christ.

Matt Slick (2022) critiques this view, arguing that Catholics believe prayer should also be directed to Mary, Joseph, and saints in heaven. Other traditions, including High Church Lutheranism, Anglo-Catholicism, Eastern Orthodoxy, and Oriental Orthodoxy, practice similar intercessory prayers (Verrett, 2021). Avi

Sion (2014) notes comparable practices in Hinduism and Buddhism, highlighting interreligious parallels.

According to Verrett (2021), the idea of praying to saints lacks clear biblical foundation and is instead rooted in extra-canonical texts, especially 2 Maccabees, which is accepted by Catholics but rejected by Protestants. Catholic theology often extends the role of saints beyond intercession; they are seen as mediators of divine wisdom and are honored as "Doctors of the Church." The Council of Trent (1545–1563) affirmed that saints who reign with Christ offer prayers for humanity (Trent, Session XXV). Early Church Fathers such as St. Jerome defended the practice. He argued that if saints could pray for others during their earthly lives, they can do so even more powerfully in heaven: "And shall their power be less after having begun to be with Christ?" (Jerome, Contra Vigilantium).

Thomas Scannell (1903) suggests that Anglican opposition to saintly intercession, found in Article XXII of the Thirty-Nine Articles, targets "Romish" abuses rather than the practice itself. In contrast, Protestant scholars such as Verrett (2021) and Slick (2022) argue that the practice contradicts biblical teaching. Verrett asserts that it relies on "centuries of complicated theology and doctrines." John Calvin emphasized that prayer is a personal practice, stating: "The principal exercise which the children of God have is to pray..." (Calvin, Institutes of the Christian Religion, III.20.1). Eliazar Daila Baba (2022) condemned praying to images or saints, declaring, "Saint Christopher [and] St. Michael cannot help us."

Arno C. Gaebelein (1912) harshly critiques prayers directed to saints, calling them "unscriptural" and an "abomination" that detracts from Christ's glory. Baba similarly insists that prayer is a "personal address to a personal God." This aligns with Jesus' teachings in the Gospels, where He instructed believers to pray privately to the Father (Matt. 6:6). Scriptural examples, such as Moses and Elijah in the Old Testament and Jesus in the New Testament, emphasize direct, solitary communication with God. The Psalms and Jesus' own prayer life provide the normative

foundation for Christian prayer (Peterson, 1997; Dugdale, 2020; Helm, 2000).

Emily Cavins (2018) acknowledges that praying to saints lacks direct biblical support but compares it to asking a friend to pray for you. While saints are no longer physically present, Catholics believe they are spiritually alive and near to Christ. However, Protestant theologians challenge this analogy, noting significant theological differences.

Four objections to saintly intercession include:

- 1. Asking fellow believers for prayer is biblical (2 Cor. 1:11; Eph. 1:16).
- 2. The Bible never instructs saints in heaven to pray for those on earth.
- 3. Saints are not omniscient and cannot hear all prayers.
- 4. Scripture condemns speaking to the dead (Lev. 20:27; Deut. 18:10–13; 1 Sam. 28:7–19).

Matt Slick (2022) offers further objections to using Revelation 5:8–14 to support saintly intercession, noting that the symbolism of Revelation does not validate the practice. He argues that heavenly awareness of prayer does not imply the appropriateness of praying *to* saints, and attributing omniscience to saints is theologically flawed. Peterson (1997) insists that prayer must be grounded in Scripture: "The scriptures, read and prayed, are our primary and normative access to God" (p. 47). Dugdale (2020) and Helm (2000) affirm that Jesus' model of prayer is the true foundation of Christian piety.

The literature reveals a deep divide between Catholic and Protestant traditions. While Catholics rely on historical tradition, theological development, and extra-biblical texts, Protestants insist on Scripture alone (*sola scriptura*). Though both seek unity through prayer, differing theological assumptions have impeded shared agreement. Thus, this study proposes a return to the prayer life of Jesus as a model. By examining how Christ Himself prayed, the church may find a path to unity rooted not in tradition or polemic, but in the example of the Son of God.

## **Theological Definitions of Prayer**

Scholars and theological writers have defined prayer in various ways throughout

Christian history. St. John Damascene described prayer as "the elevation of the mind to God with the intent of asking for appropriate things from Him" (as cited in Elwell, 1984). Similarly, Gregory of Nyssa considered prayer to be the act of communing and conversing with God, while St. John Chrysostom defined it simply as talking to God (Ferguson, 1988). John Calvin echoed these sentiments, describing prayer as an intimate communion with God (Calvin, 1541/2008). Clement of Alexandria also emphasized this communion, referring to prayer as "intercourse with God," using the term in its classical sense to denote interaction and deep communication (Elwell, 1984). In a more poetic expression, Christian A.U., a Jewish mystic, described prayer as "the moment when heaven and earth kiss each other," symbolizing the closeness required in true communion with the divine (A.U., 1997).

Johnson S. Lewis offered a more situational definition, highlighting that prayer can occur during various everyday activities, such as standing or traveling, indicating that prayer is not confined to formal settings but is a continual act of spiritual communion (Lewis, 2001). Sinclair B. Ferguson defined prayer as "a personal address to a personal God," asserting that God's selfdisclosure fosters a personal relationship which, in turn, enables authentic communication with Him (Ferguson, 1988). Edmund Clowney supported this view, emphasizing relational engagement in prayer. Wayne Grudem (1994) similarly defined prayer as "personal communication with God." Walter A. Elwell (1984) concluded that, from a biblical standpoint, prayer is both "personalistic and dialogic." Paul Helm further illustrated this by referencing the Westminster Shorter Catechism, which defines prayer as "an offering up of our desires unto God, for things agreeable to His will, in the name of Christ, with confession of our sins, and thankful acknowledgment of His mercies" (Helm, 1993, p. 47).

William E. Lori (2006), referencing the *Compendium of the Catechism of the Catholic Church*, described prayer as "the raising of one's mind and heart to God or the petition of good things from Him in accord with His will." Thus, prayer is understood as a God-directed and will-

aligned act of communication. Kent Crockett (2002) outlined four primary motivations for prayer: fostering the divine-human relationship, receiving otherwise inaccessible blessings, demonstrating the depth of personal need, and offloading burdens into God's care—affirming that "when we pray, God acts and transforms lives" (p. 57). These definitions collectively present prayer as an inherently personal and relational activity, a direct address to God expressing the desires, burdens, and faith of the individual.

#### **Praying to the Father Through Jesus**

Parkhurst (2007) emphasized that praying in Jesus' name aligns with the will of the Father, citing Jesus' statement: "For I have come down from heaven not to do my will but to do the will of Him who sent me" (John 6:38, New International Version). Parkhurst maintained that Jesus taught His disciples to pray directly to the Father in His name, without the need for any other intermediary. Joy Full (2012) noted that many Christians misunderstand what it means to ask in Jesus' name. It is not a formulaic phrase appended to the end of a prayer but rather a recognition of Jesus' authority and person. According to Full, praying in Jesus' name means seeking God's will to be done on earth, not our own will in heaven.

James T. Batchelor (2015) argued that praying in Jesus' name affirms that only through Jesus, our mediator and high priest are our prayers accepted. He concluded that Christ alone should be the center of our prayers. Matthew Henry's Commentary on the Whole Bible interprets this as an acknowledgment of our own unworthiness and an expression of full dependence on Christ's righteousness (Henry, 1710/1991). Similarly, Gill's Exposition of the Entire Bible teaches that effective prayer is grounded in the blood, righteousness, and sacrifice of Jesus. Gill (1746/1999) wrote, "His blood within the veil speaks loud for every blessing; His righteousness, God is always pleased with; His name is a sweetsmelling savour; His mediation is powerful; His name is always prevalent."

# Prayer of Intercession, Supplication, or Petition

Prayer of intercession, supplication, or petition involves a person asking God to act on

their behalf. In this form of prayer, there are no strict limitations concerning what can be requested or the scope of the plea. Jesus encouraged this form of prayer, teaching His disciples to bring their requests directly to the Father through Him. He said, "Ask, and it will be given to you; seek, and you will find; knock, and the door will be opened to you. For everyone who asks receives; the one who seeks finds; and to the one who knocks, the door will be opened" (*Matthew* 7:7–8; cf. *Luke* 11:9–10, New International Version). These passages affirm that it pleases the Father to give good gifts to His children when they ask in faith. Intercessory prayer may be offered by individuals either for themselves or on behalf of others.

According to The Catholic Encyclopedia, intercession is defined as "to go between two parties, to plead before one of them on behalf of the other" (Herbermann et al., 1910). This definition introduces the concept of praying for others while recognizing that personal prayer remains essential. Because the person in need experiences the issue most directly, they are often best suited to convey the urgency and depth of their concern to God. For instance, the story of Hannah offers a vivid example of personal, heartfelt supplication. Overwhelmed with grief and anguish, she prayed so fervently in the temple that Eli the priest assumed she was intoxicated. In truth, she was "pouring out [her] soul before the Lord" (1 Samuel 1:15, NIV). This episode highlights the deeply personal and emotional nature of genuine prayer. Even well-meaning intercessors may fail to grasp the intensity of another's burden due to their human limitations.

Nevertheless, Scripture does encourage believers to intercede for others. Paul wrote to Timothy: "I urge, then, first of all, that petitions, prayers, intercession and thanksgiving be made for all people for kings and all those in authority, that we may live peaceful and quiet lives in all godliness and holiness" (*1 Timothy* 2:1–2, NIV). This exhortation implies an expansive and inclusive view of intercession, encompassing all people regardless of status or circumstance. The Roman Catholic tradition extends the practice of intercession beyond earthly life. According to Catholic teaching, intercessory prayers may be

offered for the dead, the righteous and the unrighteous, believers and non-believers, friends and enemies alike (Catechism of the Catholic Church, 1995, §§956–957). Catholics may also seek the intercession of angels, glorified saints, and especially Mary, the mother of Jesus.

However, a survey of Scripture reveals that prayer in the Bible is always directed to God Himself, never through or to any angel, saint, or deceased person. Consider the following examples:

- Cornelius, a devout Gentile, prayed directly to God and received a divine response through an angel (*Acts* 10:1–4).
- When Peter was imprisoned, the church offered earnest prayer to God, and God responded by sending an angel to rescue him (*Acts* 12:1–11).
- Daniel consistently directed his petitions to God alone (*Daniel* 9:3–19).
- David regularly prayed to God, including in times of national and personal crisis (e.g., 2 Samuel 15:31).
- Elijah's prayers to God resulted in miraculous interventions, including drought, fire from heaven, and the raising of the dead (*1 Kings* 17–18).
- Ezra led national confession and supplication directly to God (*Ezra* 9–10).
- King Hezekiah prayed to God for healing and was granted fifteen more years of life (2 Kings 20:1–6).
- Paul offered continual prayer for believers and brought his own needs before God (e.g., 2 *Corinthians* 12:7–9).
- Jonah prayed from the belly of the fish, and God heard and delivered him (*Jonah* 2:1–10).

In all these biblical accounts, prayer is consistently directed to God, not to intermediaries. This underscores a foundational biblical principle: that prayer flows from a personal relationship with God and is addressed to Him alone.

Furthermore, Scripture offers no indication that the dead are conscious of earthly affairs or capable of interceding for the living. The parable of the rich man and Lazarus illustrates a fixed and impassable divide between the dead and

the living (*Luke* 16:19–31). The rich man's request to send Lazarus to warn his brothers was denied, demonstrating that communication between the Church Militant (believers on earth) and the Church Triumphant (the departed faithful) is neither possible nor divinely sanctioned.

Moreover, saints are not divine beings. Unlike God, they do not possess omniscience or omnipresence. Therefore, they cannot hear the prayers of millions simultaneously or intercede universally. During their lifetimes, their knowledge and relationships were limited. To suggest they can now intercede for countless unknown individuals contradicts the biblical view of their humanity and the nature of prayer. Scripture emphasizes that God alone hears all prayers and knows every heart (Psalm 139:1-4; Isaiah 42:8). The Bible also affirms that Christ is the sole mediator between God and humanity (1 Timothy 2:5). According to Grudem (2020), prayer is an act of worship and should be directed only to God, who alone possesses the divine attributes required to hear and answer prayer. Calvin (2008) similarly warns that attributing intercessory abilities to saints is a theological error, since they neither possess omnipresence nor divine knowledge. Even the Catechism of the Catholic Church (1997) acknowledges that saints act only by virtue of their union with Christ, not through inherent divine power (§§956, 2677). Thus, while saints may be honored as models of faith, they are not recipients of prayer, and claiming otherwise misrepresents their role and contradicts Scripture. While intercessory prayer is both biblical and commendable, Scripture provides no precedent for addressing prayers to anyone other than God. The Bible affirms that each believer has direct access to the Father through Jesus Christ, our only mediator (1 Timothy 2:5).

## Jesus' Model of Intercessory Prayer

Jesus' life and ministry were profoundly marked by prayer, offering the ultimate model for Christian devotion and intercession. From the beginning of His public ministry to His final moments on the cross, Jesus consistently turned to the Father in prayer, demonstrating both dependence and intimacy. He regularly withdrew to solitary places to pray (Luke 5:16), revealing

that prayer was not merely an occasional act but the foundation of His spiritual discipline. Significantly, Jesus modeled intercessory prayer. He did not only pray for Himself but frequently brought the needs of others before the Father. He prayed for children brought to Him (Matthew 19:13), for Peter that his faith would not fail (Luke 22:32), and for all future believers in His high priestly prayer (John 17:9–26). These prayers show Jesus acting as a mediator not through ritual or hierarchy, but through personal, relational communion with God. This intercession was direct, not mediated through angels or saints, underlining the biblical view that prayer and mediation are rooted in relationship with the Father through the Son.

Jesus also engaged in communal prayer. On the mount of transfiguration, He took Peter, James, and John with Him to pray (Luke 9:28). Even in such intimate moments, Jesus included others, reinforcing prayer as a shared spiritual discipline. Nonetheless, He often withdrew alone to seek the Father in private (Matthew 14:23; Mark 6:46-47), emphasizing the necessity of personal devotion. Before major decisions, such as choosing the twelve apostles, Jesus spent the entire night in prayer (Luke 6:12–13), reflecting the role of intercession in seeking divine guidance. His prayers were not directed to intermediaries, but always to the Father, whom He consistently addressed with reverence and relational closeness. When asked by His disciples how to pray, Jesus responded, "Our Father in heaven..." (Matthew 6:9), thereby establishing a prayer model focused on direct communion with God.

At the Garden of Gethsemane, Jesus exemplified intercessory struggle. He prayed intensely not only for strength to face the cross, but to align Himself with the Father's will (Matthew 26:36–46). Despite being overwhelmed with sorrow, Jesus did not call upon saints or heavenly beings; rather, He prayed directly to the Father, demonstrating that divine strength and guidance come through personal appeal to God. As He told Peter, He could have summoned twelve legions of angels (Matthew 26:53), yet He chose instead to entrust Himself to the Father in prayer. Jesus' prayers underscore several key patterns. First, they

were relational anchored in His sonship and trust in the Father. Second, they were intercessory consistently lifting up the needs of others. Third, they were instructional teaching His followers that true prayer flows from dependence on God, not ritual intermediaries. Jesus never directed His followers to pray to saints or angels. His emphasis on addressing the Father alone reveals a theological boundary for Christian prayer, one grounded in God's nature and human limitation.

As Keener (1993) notes, calling God "Father" represented a shift from formal liturgy to intimate relationship, especially within a cultural context where the father was the source and

authority of the household. This relational model of prayer reflects the believer's total dependence on God. Echoing this, Dih (2021) affirms that "We should not devise new ways of accessing the Father but remain faithful to what He has taught us in His Word."Thus, Jesus' model of intercessory prayer direct, relational, and grounded in Scripture sets the standard for Christian prayer. He intercedes not through external rites or saintly intermediaries but through the immediacy of sonship and submission to the Father's will. His life of prayer offers not only an example but a theological foundation that guards the purity and direction of Christian intercession

# Comparing and Contrasting Catholic Intercession with Jesus' Model of Intercessory Prayer

One of the most significant distinctions between Roman Catholic teaching and the model of prayer demonstrated by Jesus lies in the direction and object of intercession. In Catholic theology, it is permissible and even encouraged to invoke the intercession of saints and the Virgin Mary. This practice is supported by the doctrine of the Communion of Saints and distinctions such as latria (worship given to God alone), dulia (veneration of saints), and hyperdulia (a special veneration for Mary). Within this framework, intercession by saints is seen not as worship, but as a spiritual appeal comparable to asking a spiritually exalted friend to pray on one's behalf. Saints, it is believed, enjoy close communion with God and can intercede for the faithful from heaven. In contrast, Jesus consistently modeled prayer as a direct, personal address to God the Father. His high priestly prayer in John 17 underscores that His intercession is rooted in His divine sonship and unique relationship with the Father. The Gospel accounts offer no instance of Jesus teaching or practicing prayer through intermediaries. This divergence is stark: Catholic practice introduces secondary agents of grace, while Jesus presents a model grounded in direct access to the Father. The question this raises is whether Christ's mediatory role, if sufficient and complete, leaves room for

additional intercessors. A careful comparative analysis reveals significant contrasts in source, authority, scope, and doctrinal integrity.

## 1. Direction and Object of Intercession

One of the most significant distinctions between Roman Catholic teaching and the model of prayer demonstrated by Jesus lies in the direction and object of intercession. In Catholic theology, it is permissible and even encouraged to invoke the intercession of saints and the Virgin Mary. This practice is supported by the doctrine of the Communion of Saints and distinctions such as latria (worship given to God alone), dulia (veneration of saints), and hyperdulia (a special veneration for Mary). #### 2. Role and Nature of the Mediator

Closely related is the question of the role and nature of the mediator. Although the Catholic Church affirms that Christ is the "one mediator between God and mankind" (1 Timothy 2:5), it also holds that saints and Mary participate in a subordinate, derivative mediation. Mary, in particular, is often referred to as "Mediatrix of all graces," reflecting her special place in salvation history and ongoing intercession. By contrast, Jesus clearly claimed exclusive mediatorship: "No one comes to the Father except through me" (John 14:6). His mediatory role is grounded not in ecclesiastical status or spiritual merit, but in His divine identity and redemptive mission. Nowhere in Scripture does Jesus delegate this role to another. The New Testament presents Him as the sole High Priest who intercedes for believers (Hebrews 7:25), highlighting a Christcentered, non-hierarchical view of spiritual mediation. Thus, the Catholic structure of layered intercession contrasts with the exclusivity and sufficiency of Christ's role in the New Testament.

# 3. Basis and Authority for Intercession

The basis and authority for intercession also reveal a key theological divide. Catholic practice is supported by Sacred Tradition, ecumenical councils especially the Council of Trent and the Catechism of the Catholic Church (e.g., §§956, 2683). These sources affirm that saints in heaven can hear prayers and respond universally, though this capacity is not explicitly taught in the Bible. Jesus' model, however, draws its authority directly from divine revelation. His intercessory role is grounded in His divine sonship (John 10:30) and affirmed by acts that demonstrate His unique access to the Father (John 11:41-42). His prayer life was not institutional or delegated but ontological rooted in His nature as God the Son. This raises the question of whether ecclesial tradition can legitimately introduce practices that have no clear foundation in Jesus' own teachings or actions.

## 4. Accessibility and Scope of Intercession

In terms of accessibility and scope, the Catholic Church teaches that saints can be invoked according to their areas of spiritual patronage for example, St. Jude for hopeless cases. However, as finite creatures, saints are limited in their ability to respond. Their intercession is necessarily restricted by their created nature. By contrast, Jesus' intercession is universal and limitless. As the resurrected and exalted Lord seated at the right hand of God, He is able to intercede for all people at all times (Romans 8:34; Hebrews 7:25). His divine attributes omniscience, omnipresence, and omnipotence ensure that no request is beyond His reach. Therefore, Christ's intercession is not only theologically unique but also practically superior in scope and sufficiency.

## 5. Practical and Pastoral Implications

There are also practical and pastoral implications to consider. Catholic devotional life often includes prayers to saints and Mary, which can create a sense of spiritual companionship and familiarity. For many, these figures serve as comforting intermediaries when one feels unworthy to approach God directly. Yet, Jesus dismantled such barriers. He invited all believers to approach the Father boldly: "Ask and it will be given to you..." (Matthew 7:7). His model eliminates fear and fosters intimacy with God. Every Christian, regardless of their spiritual maturity, is welcomed into the presence of God through the merits of Christ alone. While prayers to saints may offer emotional solace, they may also obscure the direct and confident relationship believers are meant to have with the Father.

#### **6.** Doctrinal Consistency

Finally, the issue of doctrinal consistency must be addressed. Defenders of Catholic intercession frequently cite Revelation 5:8 and 8:3–4 as evidence that saints present the prayers of the faithful to God. However, these apocalyptic texts are symbolic in nature and open to multiple interpretations. Moreover, no scriptural passage explicitly endorses prayer *to* saints. By contrast, the New Testament clearly teaches the sufficiency of Christ's intercession and the believer's direct access to God (Philippians 4:6–7; Hebrews 4:16). Jesus never advocated for or modeled prayer

involving saintly intermediaries. His example and instruction establish a normative framework for Christian prayer that is grounded in Scripture and secured by His divine identity.

While Catholic intercessory practices are shaped by centuries of tradition and ecclesial authority, Jesus' model of intercessory prayer grounded in Scripture and divine sonship offers a direct, sufficient, and accessible relationship between the believer and God. The theological and pastoral implications of this difference call for critical reflection and a return to Christ-centered prayer rooted in the New Testament witness.

#### Conclusion

Jesus' model of prayer teaches that it is both biblically and theologically incorrect to direct prayer to anyone or anything other than God the Father. True Christian prayer is characterized by direct communion with the Father, as consistently demonstrated in the life and teachings of Jesus. He instructed His disciples, "This, then, is how you should pray: 'Our Father in heaven...'" (Matthew 6:9, NIV), affirming that prayer should be intimate, personal, and God-focused. Luke further confirms that it is the Father who responds to the prayers of believers: "How much more will your Father in heaven give the Holy Spirit to those who ask him!" (Luke 11:13, NIV), and James echoes, "Every good and perfect gift is from above, coming down from the Father of the heavenly lights..." (James 1:17, NIV). This divine responsiveness reflects the biblical mandate for prayer to be directed solely to God, who alone possesses the attributes of omniscience, omnipresence, and omnipotence.

Yet, despite this clear instruction, some theological traditions particularly within Roman Catholicism have developed practices of praying to saints and invoking their intercession. This development is often rooted in human-centered reasoning and theological humanism, which assume that certain individuals, because of their holiness, are more worthy to stand before God on behalf of others. Such a view suggests that believers are too unworthy to approach God directly and therefore need intermediaries. However, Jesus' own prayer life refutes this idea. He regularly approached the Father with boldness

and invited His followers into the same direct access (cf. John 16:23; Hebrews 4:16). His intercessory example, including His prayer for Peter (Luke 22:32) and His high priestly prayer for all believers (John 17), consistently modeled direct communication with the Father rather than through third parties.

This paper argues that the practice of praying to saints lacks both biblical precedent and theological coherence. Saints, being human and finite, do not possess the divine attributes necessary to hear or respond to the prayers of countless individuals across time and space. The notion that the dead can universally intercede for the living contradicts both the biblical view of human nature and the exclusive mediatorship of Christ: "For there is one God and one mediator between God and mankind, the man Christ Jesus" (1 Timothy 2:5, NIV). In conclusion, a return to Jesus' model of intercession reinforces that Christian prayer must remain grounded in a personal and direct relationship with God the Father through Jesus Christ, excluding the need for saintly or angelic mediation.

### Recommendations

### i. Reaffirm Biblical Norms for Prayer

Catholic teaching and practice should be continually re-evaluated in light of the clear biblical precedent for prayer directed to God the Father through Jesus Christ. Church leaders and theologians are encouraged to reemphasize Jesus' model of prayer as normative for Christian life (Matthew 6:9; John 16:23). Scripture alone should define the boundaries and content of intercessory prayer to ensure doctrinal faithfulness.

# ii. Re-examine the Role of Saints in Devotional Practice

While the veneration of saints is historically significant in Catholic tradition, the Church should re-examine this practice theologically, especially in terms of whether it aligns with the unique mediatorship of Christ (1 Timothy 2:5). The faithful should be clearly taught the difference between honoring saints and the act of prayer, which belongs solely to God.

## iii. Encourage Direct Personal Communion with God

Pastoral teaching should prioritize empowering believers to approach God directly with

confidence, as taught in Hebrews 4:16. Believers should be discipled to understand their spiritual access to the Father through the Son, rather than relying on saintly intermediaries out of a sense of unworthiness or tradition.

# iv. Clarify Doctrinal Teaching on Intercession

Catholic catechesis should distinguish between intercessory prayer by the faithful on behalf of others (a clearly biblical practice), and intercessory prayer to saints (a post-biblical tradition). Greater

theological clarity is needed to prevent confusion and to safeguard the integrity of prayer as communion with God.

# v. Focus on Christ as the Sole High Priest and Intercessor

The Church should consistently center its theology of prayer around Christ's high priestly ministry (Hebrews 7:25). Teaching and liturgy should highlight His role as the exclusive mediator and intercessor for believers, in order to preserve the Christocentric focus of Christian devotion.
